Speaker(s): Aaron Tomarchio, Sr. Vice President, Tradepoint Atlantic – Aaron presented a slide show of Ariel views of the grounds. Some of the topics he addressed are as follows:

- 22 acres adjacent to community working with Parks and Recreation and Baltimore County to develop off Wharf Road.
- Marine Terminal is being worked on
- Fed Ex being on site has brought more market interest
- Some current businesses on site Aluma Safeway, Under Armor, Amazon, Floor Décor, Home Depot, Port, Gotham Greens (hydroponics). There are 20 tenants and increasing which has brought 5,000 jobs. Some new business coming are Royal Farm and Off Shore Wind manufacturing.
- Other retail will come later. We need to have a planner that works with retails assist us.
- Environmental clean-up is continuing
- Wharf Road will be under construction during 2020. Once that is complete there will be more planning/resolution regarding the road paths to ease the congestion of traffic. This will include internal signage for way finding as well as ramps/entrances, wider roads and turning issues around the site for better direct access to locations. In addition, working with zip code/GPS coordinates to help with truck driver errors.
- Looking at opportunities for electrical vehicle charging.
- Solar company interest.
- Port modifications will allow manufacturing materials to arrive i.e. marble, lead ingots, coal etc. The use of the rail and trucks will be a big asset.
